Metro Assist, a not for profit organisation, is seeking a highly experienced Caseworker to join our Brighter Futures Program. The Brighter Futures program delivers targeted early intervention services to families with children who are at high risk of entering or escalating within the statutory child protection system. The program services families with children aged less than 9 years, or families expecting a child, by providing intervention and support that will achieve long-term benefits for children. Metro Assist works specifically with families of culturally and linguistically diverse (CALD) backgrounds to provide tailored support through casework, structured home visits, parenting programs and some brokerage. The program is designed to support families to stay together and to prevent the escalation of concerns for children transitioning into the statutory child protection domain. The Brighter Futures program uses a strengths-based approach within an evidence based outcomes framework.

The ideal candidate will possess extensive experience in casework and case management to families, children and young people who are at risk of further escalation within the Child Protection system.

### **ESSENTIAL SELECTION CRITERIA**

1. Demonstrated experience in casework/case management roles in early childhood/family support/welfare sector
2. Relevant tertiary qualifications
3. Bilingual speaker in Arabic and/or Vietnamese
4. Demonstrated ability to engage families from diverse backgrounds and cultures, working in partnership with them to achieve their goals and address child safety concerns using a range of intervention strategies
5. Strong understanding of child-centred practices for the needs of children, families and people from culturally diverse backgrounds, while delivering an evidence based outcomes framework
6. Demonstrated understanding of issues facing vulnerable families; principles of early intervention; and of children’s developmental stages and practical parenting skills
7. Proven ability to maintain accurate and thorough case notes and complete reporting requirements to the highest standard
8. Strong interpersonal skills and demonstrated experience in developing professional and interagency relationships
9. Possess current full driver’s license and access to a vehicle with comprehensive insurance, and prepared to undergo a Police and a Working With Children Check
